I accept any and all responsibility for any medical condition or injury resulting from my participation. I hereby give to Scott Fray his heirs, legal representatives and assigns, those for whom Scott Fray is acting, and those acting with his authority and permission:

a) the unrestricted and irrevocable right and permission, throughout the world, to copyright and use, re-use, publish, and republish photographic or video images or pictures of me or in which I may be included intact or in part, composite or distorted in character or form, without restriction as to changes or transformations in conjunction with my own or a fictitious name, or reproduction hereof in color or otherwise, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose whatsoever.
